





Skills for Care is the strategic workforce development and planning body for adult social care in England. We work with employers, Government, and partners to ensure social care has the right people, skills, and support required to deliver the highest quality care and support, now and in the future. Our role is to respond and adapt to the emerging trends and needs within social care, using data and evidence to drive forward widescale change.

The information within this summary has been produced by Skills for Care using the Adult Social Care Workforce Data Set (ASC-WDS). We use the data collected by the ASC-WDS to create workforce models that, in turn, allow for estimates of the whole adult social care workforce and its characteristics to be produced. The \* notation indicates the figure has been suppressed.

#### Size and structure of the workforce

In 2023/24 the adult social care sector in England had an estimated 18,500 organisations with 40,000



care-providing locations and a workforce of around 1.84 million posts.

The total number of posts in Warrington was around 9,300 in 2023/24. This was comprised of 8,800 filled posts and 550 vacant posts across all sectors.

Since the previous year, the total number of posts were similar, the number of filled posts has increased by 150 (2%) and the number of vacancies has decreased by 100 (16%).

The estimated 8,800 filled posts were split between local authorities (7%), independent sector providers (81%), posts working for direct payment recipients (6%) and other sectors (5%).

In 2023/24, the CQC register showed there were 111 regulated services in Warrington; 56 were residential and 55 were non-residential services.

If the workforce grows proportionally to the projected number of people aged 65 and over then the total number of adult social care posts in the North West region will increase by 23% (from 260,000 to 320,000 posts) between 2023/24 and 2040.

From here on, the figures in this report refer to the 7,800 filled posts in the independent sector and local authority only. Filled posts in other sectors are not included.

The independent sector information in this report was collected between April 2023 and March 2024, and local authority information dates from September 2023.

#### Recruitment and retention

Skills for Care estimates that the staff turnover rate in Warrington was 27.5%, which was similar to the region average of 25.4% and higher than England at 24.8%. Not all turnover results in workers leaving the sector, around two thirds (62%) of starters were recruited from within the adult social care sector, therefore although employers need to recruit to these posts, the sector retains their skills and experience.

We estimate that the vacancy rate in Warrington was 6.4%, which was similar to the regional average of 7.5% and similar to England at 8.1%.

Across England, the vacancy rate has decreased compared to last year and the number of filled posts has increased. During this period international recruitment increased which has impacted these trends.

Workers in Warrington had on average 11.2 years of experience in the sector and 83% of the workforce had been working in the sector for at least three years.

Skills for Care have also collaborated with the adult social care sector and people who draw on care and support to develop a <u>Workforce Strategy</u>, which includes <u>attraction recommendations and commitments</u>.

### **Employment information**

We estimate Warrington had 7,800 adult social care filled posts in the local authority and independent sectors. These included 650 managerial roles, 350 regulated profession roles, 6,000 direct care (including 4,700 care workers), and 850 other-non-care proving roles.

The average number of sickness days taken in the last year in Warrington was 6.6, (6.8 in North West and 5.3 across England). With an estimated directly employed workforce of 6,900, this means employers in Warrington lost approximately 46,000 days to sickness in 2023/24.

Around two thirds of the workforce (65%) usually worked full-time hours in Warrington and 35% were part-time.

Less than a quarter (15%) of the workforce were on zero-hours contracts.

## **Workforce demographics**

The majority (77%) of the workforce in Warrington were female, and the average age was 42.7 years old. Workers aged



under 25 made up 11% of the workforce and workers aged 55 and above represented 25%. Given this age profile approximately 1,900 posts will be reaching retirement age in the next 10 years.

Across England 73% of the workforce identified as British, while in the North West region this was 84%. An estimated 81% of the workforce in Warrington identified as British, 16% identified as of a non-EU nationality and 3% identified as of an EU nationality, therefore there was a higher reliance on non-EU than EU workers.

#### **Pay**



Table 1 shows the full-time equivalent annual or hourly pay rate of selected job roles in Warrington (area), North West (region) and England. All figures

represent the independent sector as at March 2024, except social workers which represent the local authority sector as at September 2023. At the time of analysis, the National Living Wage was £10.42.

# Qualifications, training and skills

We believe that everyone working in adult social care should be able to take part in learning and development so that they can carry out their roles effectively. Learning and development helps everyone to develop the right skills and knowledge to enable them to provide high-quality care and support.

Skills for Care estimates show that 46% of the direct care providing workforce in Warrington hold a *relevant* adult social care qualification (49% in North West and 47% in England). Raw data from the ASC-WDS showed, of those workers without a relevant adult social care qualification recorded, 30% had five or more years of experience in the adult social care sector, 53% had engaged with the Care Certificate and 67% had completed training.

#### **Factors affecting turnover**

Together with a data science specialist, we used ASC-WDS information to create machine learning models that were used to assess which variables had an effect on adult social care workers' propensity to leave their posts.

# Across England, variables that influence the likelihood of a care worker leaving their role were:

- Workers who travelled further were more likely to leave.
- Those under 25, and over 60 years old, were more likely to leave their posts.
- Turnover decreased with higher levels of experience working in the sector.
- Likelihood of leaving decreased as pay levels increased.
- Likelihood of leaving decreased with higher levels of experience in role.
- Likelihood of leaving decreased if workers had more training.
- Turnover decreased if workers had a higher number of contracted hours.
- Likelihood of leaving decreased if workers had fewer sickness days.
- Workers on zero-hours contracts were more likely to leave their posts.
- Likelihood of high turnover rates increased if the establishment had high turnover historically.
